I'VE BEEN IN A CAR ACCIDENT. WHAT SHOULD I DO?

Introduction

If you or a loved one have been injured in an auto accident, you are dealing with an incredible number of stressful issues. Your injuries may be significant, even disabling and you have immediate medical concerns and expenses. You may be facing time out of work, which means lost wages and you're dealing with one or more insurance companies and a mountain of bewildering paperwork.

You may have been told by your insurance company that you don't need an attorney and that they will handle the claim for you. However, it's important to remember that your insurance agent DOES NOT work for you. Your agent is not trained to help you figure out your legal rights. His/her objective? To have the insurance company pay as little as possible.

This is why it's very important to consult with an attorney experienced in auto accidents and New York Personal Injury Law as soon as possible. An attorney with the right experience will examine your case and work closely with you and your family to decide on the right course of action, given the circumstances of your accident.

We've put together the following reference to help you immediately following an accident.

Do's and Don'ts for Auto Accidents

If you've been injured in an auto accident, there are some important actions to take immediately:

- ✓ **DO contact your car insurance company as soon as possible.**
 - ✓ **DO follow your doctor's instructions.** Keep all medical appointments.
 - ✓ **DO record the circumstances of the accident.** Take digital pictures of the vehicles involved, as well as the accident site. Get someone to help you photograph your injuries. Record the names and contact information of other drivers as well as any witnesses.
 - ✓ **DO obtain a copy of the police accident report.**
 - ✓ **DO keep a written account of all conversations with insurance companies, agents and the police.**
 - ✓ **DO read all documents from both insurance companies carefully.** You may settle and release your property damage claim with the other person's car insurance company, but only after carefully studying the release agreement.
 - ✓ **DO cooperate with your insurance company.**
 - ✓ **DO check your insurance company's filing deadline.** There is a limit to the amount of time you have to file a claim, so make sure time doesn't run out.
 - ✓ **DO be careful with information on social media.** If you use social media like Facebook or Twitter, be aware that any postings, comments or photos can be used against you in your auto accident claim.
- In addition to the steps outlined above that you must take after an auto accident, here are a few things you should avoid:*
- ✗ **DON'T give a recorded statement to the other person's insurance company.**
 - ✗ **DON'T sign a medical release for the other person's insurance company.**
 - ✗ **DON'T go to a medical exam with an insurance company doctor.** An exam for a "second opinion" may be an excuse to stop or delay payments. Check with your attorney before attending the examination.
 - ✗ **DON'T accept a check for your personal injuries.** Be sure NOT to sign any release for a personal injury claim or accept any payment without consulting with your attorney.
 - ✗ **DON'T admit any liability on your part.** The insurance investigators will determine liability based on many different factors. Stick to the facts in any conversations.

When asked by the insurance adjuster, should I sign off on my medical claims?
